We at the NAWA have recognized for many years that in most cases the "Operator" is responsible for both water and wastewater operations, that's why this training opportunity is covering both topic areas. Special attention will be placed on the topics of flow monitoring, Clean Water Act and Safe Drinking Water Act. Topic discussions are supplemented by PowerPoint presentations, case photos, worksheets and presentation handouts will be provided to attendees.
